Driven by an entrepreneurial spirit, she then embarked on a fund project focused on special situations to support underperforming companies, before joining Rives Croissance, a minority-stake fund, for three years, and subsequently Arkéa Capital in Bordeaux, also specialised in minority equity.

Within Épopée Gestion, Gaëlle Tanguy's mission will be to identify and support high-growth SMEs and mid-caps across Nouvelle-Aquitaine and Occitanie, drawing on her deep knowledge of the regional entrepreneurial ecosystem and her expertise in both minority and majority equity transactions.
